"The World's Luckiest Fishing Village" Where Fishing Tournaments Abound This Season

Fishing Tournaments have been one socially distant way to get outside with friends this summer and participate in a fun activity. This year was the 2nd annual Boathouse Oyster Bar Summer Slam Fishing Tournament that happened from June 1 to August 9.

State and Federal Water Charter Boats, as well as private anglers, could register at least 24 hours prior to weighing fish in on the scales at the Boathouse. Their own weighmaster Amber (Jack) Helton, a former Miss Destin, was stationed at the scales for the entirety of the summer. The tournament concluded with a Garbo World Championship on August 1, where Federal boats had one day to catch Pounders, Grouper, Greater Amberjack and Red Snapper and weight them in for a special prize.

As to not leave the kids out, the Boathouse Oyster Bar also put on a Kids Fishing Tour-



namment the last week of July, where 44 kids went out on the American Spirit Party Boat to try their luck. The crew helped bait hooks, reel in fish, and take the fish off the hook.

Once they returned to the docks, the fish were weighed in and the kids took photos with their catch. A fish fry followed, with all proceeds being donated to charity.

The next upcoming tournament is the 11th Annual Big Mac Classic, held at AJs Seafood and Oyster House in Destin, September 18-20, 2020. \$10,000 is at stake for the team to bring in the largest King Mackerel to the scales. Boats can register for \$450 per boat with proceeds benefiting the Ronald McDonald House. While this is mainly a King Mackerel tournament, there are cash prizes available for the largest wahoo, dolphin, and blackfin tuna as well. Scales will be open from 3-7pm on Saturday and 12pm-5pm on Sunday behind AJs.

The largest and most popular tournament, the Destin Fishing Rodeo, is also happening this year and is one of our most highly anticipated events here in Destin. Anglers of all ages and charter boats alike are excited and geared up to compete for the first place prize.

Shelter House Offers Protection and Healing

Someone is sexually assaulted every two minutes in the U.S. One out of every six women, and one out of every 33 men experience an attempted or completed rape in their lifetime.

Fact: One in every four women will experience domestic violence in her lifetime. According to the Bureau of Justice Statistics, on average, more than three women and one man are murdered by their intimate partners in this country every day. In 70 - 80% of intimate partner homicides, no matter which partner was killed, the man physically abused the woman before the murder.

In 2018 In Okaloosa County, there were 11,907 forcible sex offenses leading to 2,562 major arrests. There were also 2,238 non-forcible sex offense arrests. 60% or more cases are not reported to law enforcement.

Along with sexual assault and offenses, there is domestic violence

An Angel Among Us

Our Hometown Hero, Vickie May Edge, lived life full on. She was the light in every room she walked into until the morning of Aug. 6, 2020, when the light and life was taken from her. She loved deeply, lived faithfully, and gave anything and everything she could to any and everyone who had a need. If she only had \$10 in the bank, she would find \$40 for someone if

they needed it—and she always knew who was in need because she cared enough to really talk to and get to know people. She had so many different pods of friends, because of her ability to make deep connections.

She loved her son Chase deeply and supported and loved him through some of the hardest times in his life. Her brother Derrick Edge was her hero, even at the end. She also loved

her “adopted daughter,” Chameron Perry, who had worked faithfully by her side for 14 years and would be the one to take over her business, Edge of Paradise Day Spa in Destin. She had been grooming her for that for years. And, Chameron is keeping Vickie’s business alive.

Vickie wanted a fairytale life and she deserved that for all she had done for others. I work with United for a Good Cause,

Inc., and when we launched our HOPE Squad Suicide Prevention program for the schools, she was the first to step up and coordinate a fundraiser for us. At Christmas, when someone had 60 bikes for us to give away, I knew who to call. Vickie got friends from all around to come pick them up and deliver them to the north end of the county where there were some children in need. She loved supporting

Shelter House – our local agency for Domestic Violence and Sexual Abuse. She was always buying food or items needed to take there. She always helped with fundraisers and in February this year, she reached out to all she knew and asked for donations for items to go in goody bags. She made up beautiful little bags of joy so every woman and child in the shelter would

which not only affects the victim, but also affects the family members that witness it, particularly the children.

Fact: Nationwide, one in every four women will experience domestic violence in their lifetime. An estimated 1.3 million women are victims of physical assault by an intimate partner each year. It is estimated that anywhere between 3.3 million and 10 million children witness domestic violence annually. Boys who witness domestic violence are twice as likely to abuse their own partners and children when they become adults. Thirty to 60% of perpetrators of intimate partner violence also abuse children. Most domestic violence cases go unreported.

In 2019 in Okaloosa County, there were 1,246 domestic violence offenses and 820 major arrests.

These statistics are why Shelter House, based in Fort Walton Beach, is so incredibly important. **Shelter House, Inc., is the only state-certified domestic and sexual violence center serving victims of Okaloosa and Walton counties and offers a variety of services to families in need. All services are free and confidential.**

In 2013, Shelter House be-

came the only domestic violence shelter in Northwest Florida to allow pets, as they realized that many people stay in abusive situations because there’s no place for them. The shelter is a home-like environment and discretely houses victims and their children in abusive or violent situations, and even abandoned/victimized kids 12 and up. Here they can stay for up to eight weeks living in a safe, protected place to escape any unhealthy situation to gain strength, healing and guidance. They have locations in Fort Walton Beach, Crestview and DeFuniak Springs where survivors can meet with advocates for peer counseling, food pantry, support group and referrals to other community resources. There is even a federally funded apartment program where rent and deposits are initially covered with support reduced over time as the participant becomes more independent. Today, services provided include confidential shelter, court advocacy, peer counseling, support groups, primary prevention, transitional housing, economic empowerment workshops, 24-hour domestic violence hotline, 24-hour sexual assault helpline, child therapy services and supportive services for family members of sexual violence victims. In a single year, right here in our community, Shelter House provides emergency shelter to more than

220 adults and children, houses more than 45 women and children in transitional housing apartments and provides services to nearly 400 adults and children through outreach. “And there are so many more who have not yet reached out to us,” says Rosalyn Wik, Executive Director.

Shelter House also provides various services to sexual assault survivors, ages 12 and up, whether the abuse happened recently or years ago. In order to comfort, support and protect victims, an advocate on the Rape Response Team (RRT) will accompany victims during forensic examinations and law enforcement interviews and support the victim and plead his or her rights. In certain cases, such as when the perpetrator lives with the victim, sexual assault victims are welcome to stay in the emergency shelter. Advocates can provide legal advocacy to victims and support for friends and family of survivors who need help supporting the victim and dealing with their own feelings.

Through community fundraisers, the program has grown to what it is today. The emergency shelter has acquired special examination equipment for sexual assault victims which is a great help with the shelter’s costs of helping these beautiful individuals in need.

Local events held through Destin Charity Wine Auction Foundation, Little Black Dress Party, White Wilson Medical Centers, and Walk Her Way 5k support Shelter House. Upcoming is Purses with a Purpose in September where Shelter House will be the beneficiary.

If you’d like to donate, visit ShelterHouseNWFL.org for items needed. “Food, cleaning products, personal hygiene items and gift cards are always welcome as well as monetary donations,” says Rosalyn, “and we are always in significant need of toilet paper and paper towels.”

“We know that sexual assault happens in every community, including ours, but we also know that many victims are too afraid or ashamed to report it to the police or even talk about it with their closest confidant,” says Rosalyn. “We are here for those victims – whether the assault happened today or decades ago – to provide continuous support, services and advocacy. And to our Shelter supporters, as always, thank you for being a friend and advocate for survivors of domestic and sexual violence. We could not fulfill our mission without you!”

Gateway to Crystal Beach

The "Gateway to Crystal Beach" is now on its way to becoming a reality thanks to the partnership between the City of Destin, the Okaloosa County Board of County Commissioners, the Tourist Development Council and Trust for Public

Land. The City of Destin has pledged \$9,000,000 and Okaloosa County \$13,000,000 for potential beach acquisitions to expand beach access in Destin for residents and visitors. The Trust for Public Land, which the City of Destin has partnered with to aide in the process, has been negotiating with three properties adjacent to the Shore of Crystal Beach Park. All three are under an option/purchase agreement with the Trust for Public Land. The combined cost of these acquisitions is \$10.6 Million plus some ancillary closing costs which are (estimated under \$50,000). Funding for the initial set of acquisitions is proposed to be funded with the following ratio — 59% County (TDC) (\$6.28+ Million) and 41% City (\$4.37- Million), based on the dollars pledged by the city and the county. Completion of the project is anticipated for 2021.



Acquiring public beach is the Destin City Council's top priority in the city's 2020 strategic plan. "Many of us who grew up here know that over the last two decades, we have not seen the beach when driving down old Highway 98," said Councilman Parker Destin. "This will be the

first time that you can see the beach, in an old Destin fashion, in decades."

receive a Valentine gift. The baffling irony is she was brutally murdered by a boyfriend she met online, and was killed during an act of domestic violence.

Recently, she made the decision to give her biggest gift of all – to help a friend she had only known well for a relatively short time. That friend, Kathy Houchins, is in dire need of a kidney transplant and Vickie was planning to be her donor. She felt God had called her to do that and when she got tested, she was a near perfect match. Planned for January, we had started a big campaign to pay for the transplant as both donor and patient incur extra expenses outside what the insurance pays.

Sadly, on Tuesday before her death on Thursday, Vickie was diagnosed with Stage 2 colon cancer and was told she could no longer be a donor. On Wednesday, we all cried together as I sat with Kathy and Vickie on the phone as she told her the news. That whole day, she kept saying, “Don’t worry, I am going to find you a donor – I promise we will

get you a kidney.” She wasn’t worried about the fact she had cancer—only that she needed to find another donor to replace her. That was how she spent her last day on this earth...trying to help a friend in need.

In May she had met a guy on Facebook Meetup from Milton that she believed to be her soulmate and prince in shining armor. He promised her the sun, the moon and the stars and

rushed her to get married in October, because he couldn’t live without her. She was finally getting her fairytale. He was buying her a new house on the lake where she wanted to live, giving her a new car for a wedding present, even buying her son a truck. He even had their names tattooed on his arm the week before he killed her, knowing that was his ultimate plan. She was so caught up in the fairy-

tales romance, she didn’t realize he had begun controlling every minute of her time, separating her from friends, talking her into staying with him and missing work because he couldn’t be without her. When he wrote her the \$15,000 check that he knew would bounce to pay for the wedding, since all he had told her had been a lie, he decided the only way out was to brutally murder her. I won’t share the details of what a monster he really was—this story is about the wonderful woman he took from us all and what she would want every woman to remember as they search for that fairytale.

Vickie did a background check – it was clean. What she didn’t do is speak to an ex-wife. She would have found out he had anger issues. What we believe she would tell you is to slow down, take your time to REALLY get to know someone. If they want to consume all your time, that is not about love—that is about control and neediness. If they are always patting themselves on the back about how wonderful they are, that is narcissistic behavior and that can be dangerous, because they might decide that if they

can’t have you, then they don’t want anyone else to. It’s ok to ask to see their financials if they are asking you to marry them.

What she would also want you to know is to live a full life each day. Leave a legacy of giving so others may live and enjoy even just one moment in life because of something you did for them without ever taking credit for it. If you would like to honor this wonderful woman’s memory, there were things she was passionate about raising money and awareness for—Shelter House www.shelterhousenwfl.org; the HOPE Squad Suicide Prevention & Awareness program www.bringhopenow.com; or give the ultimate she was willing to give – be a kidney donor for Kathy or **donate to the transplant fund so that when a donor steps forward, the surgery can happen right away.** www.helpopelive.org/campaign/17417. Although not as she would have wanted it to go, she got her ultimate fairytale as she now has golden angel wings and sits in the arms of her Lord and Savior. Let us all be like Vickie and keep her legacy alive.

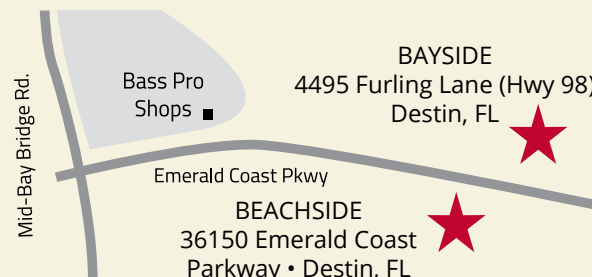

DCWAF Raises over \$1.35 Million for NW Florida Children Through its First Virtual Auction

Destin Charity Wine Auction Foundation (DCWAF) celebrated the 15th Annual Destin Charity Wine Auction presented by the Jumonville Family through a new virtual format on August 22. DCWAF is pleased to announce that the event raised \$1.35 million for children in need in Northwest Florida, despite the many challenges presented by COVID-19.

“We are so very grateful for the support of our board, our business community, and so many wineries that played a role in helping us produce the 2020 auction,” says DCWAF President John Russell. “The fact that we could raise over \$1.35 million for children’s charities while maintaining a safe environment for all is proof that we

can continue to make positive impacts in our communities despite the pandemic. The lesson we learned is don’t stop fighting to find a way forward.”

The auction, originally scheduled for the last weekend in April, has overcome a number of challenges during its anniversary year to include rescheduling to August before moving to a fully virtual format. The funds raised far exceeded the Foundation’s fundraising goal and are trending above the national average for funds raised through virtual charity auctions.

The live auction portion of the event was held simultaneously with a live broadcast streamed on YouTube from the Hilton Sandestin Beach Golf Resort and Spa. Hosted by auc-



ioneer Ursula Hermancinski, friends from throughout the Foundation’s 15-year history sent in messages of support to kick off the live broadcast. Prior to the 2020 auction, DCWAF had yet to break the \$100,000 barrier for a single-sale live lot. DCWAF is pleased to announce that this year’s auction boasted two record-breaking lots, an immersive trip to Dakota Shy and Triple Creek Ranch featuring Honorary Vintner Todd Newman and Honorary Chef Tim Creehan which sold for \$105,000 and a trip to Virgin Gorda with the Phelps family that sold for \$100,000. Other notable lots included a seven-day trip donated by Steve & Bridgit Griessel of Betz Family

Winery to the South African winelands and Molari Lodge which sold for \$50,000 and a once in a lifetime trip to the Cayman Cookout, which sold twice for a total of \$70,000.

The funds raised at the annual auction are distributed to 16 local non-profit organizations for specific projects and programs that benefit children. Charity partners for 2020 include Ascension Sacred Heart Emerald Coast, Children in Crisis, Children’s Volunteer Health Network, Emerald Coast Autism Center, Emerald Coast Children’s Advocacy Center, Food for Thought, Habitat for Humanity of Walton County, The Arc of the Emerald Coast, Opportunity Inc., Pathways for Change, Shelter House of Northwest Florida, AMIkids Emerald Coast, Boys and Girls Clubs of the Emerald Coast, Mental Health Association of Okaloosa and Walton Counties, Westonwood Ranch, and Youth Village.

The Auction was comprised of 29 unique Live lots, 6 Almost Live lots, 29 Super Silent lots and 131 Silent lots with 64 generous sponsors. In an unprecedented act of generosity, all sponsors agreed to continue their support after DCWAF was forced to cancel all in-person events due to COVID-19.

In addition to the virtual auction festivities, long-time DCWAF supporters got creative in finding ways to support the Foundation. Wine World donated a portion of their wine retail sales during the month of August leading up to the event. Trustees Bill & Cheryl Stegbauer matched the sales at Bijoux on Friday, August 21 in a donation to DCWAF of \$15,800, and Bijoux owners Jack and Leslie McGuckin generously contributed an additional \$5,000. For those still wishing to support DCWAF, Revana Estate is contributing a portion of their 2017 Estate Cabernet Sauvignon wine sales to DCWAF until the end of the month. As the top charity fundraising event in Northwest Florida, the Destin Charity Wine Auction has been ranked among the nation’s top 10 highest-grossing charity wine auctions in the country by Wine Spectator Magazine for seven consecutive years and is currently ranked sixth. 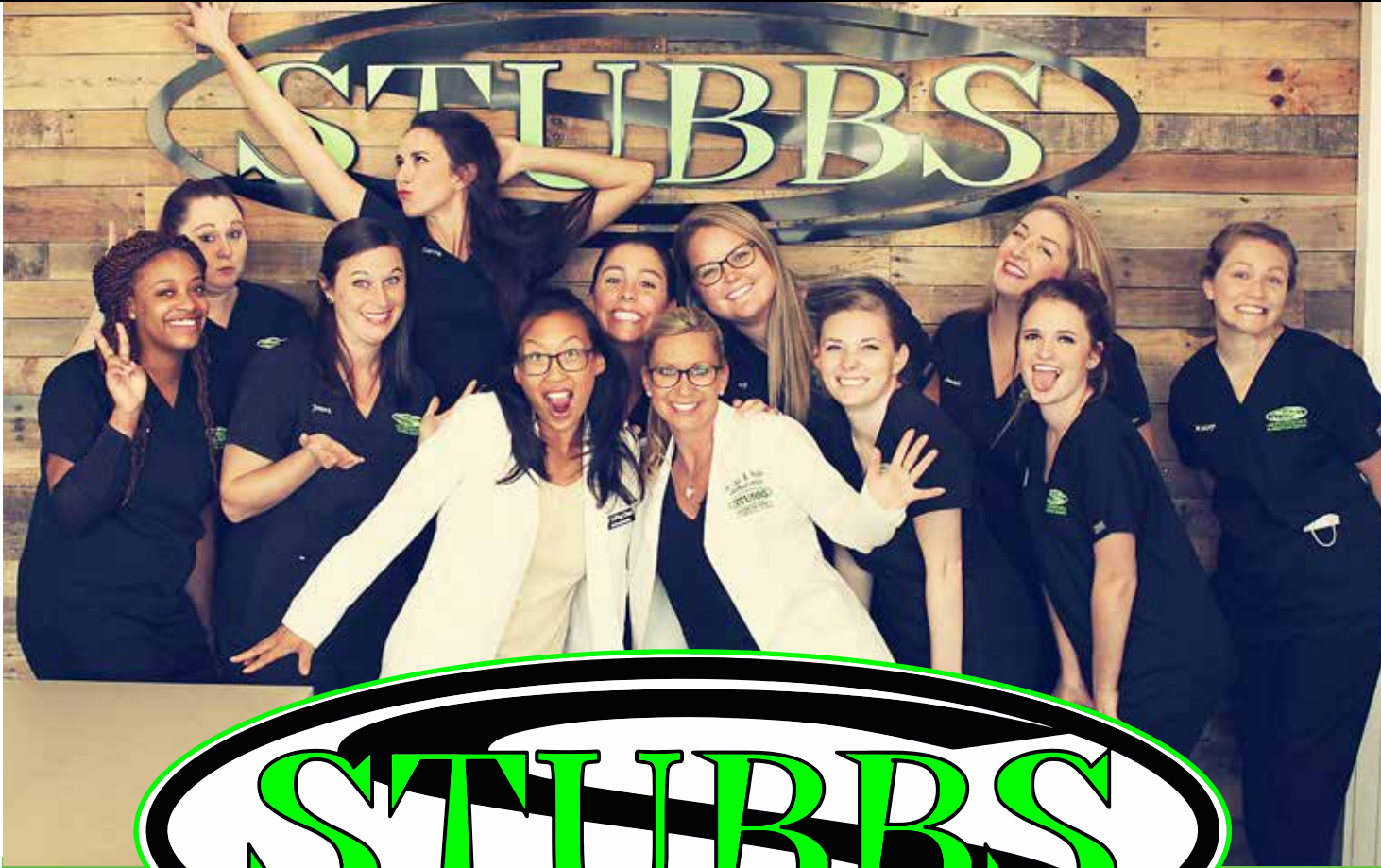

But dentures or no dentures, our heroine proceeds to go on the offensive taking care of business again, leaving our lion friend wishing he never met her.

Now let's leave this drama and enter another.

Scene: Niceville, Florida. USA. An age 70 widow just returns home after a long weekend. The AC line has overflowed. There's water everywhere. She calls for help.

YEAR: 2013

Day 1: Restoration efforts begin to dry out the house. It's a modest home in Niceville, a typ-



ical Florida style rancher with a brick face. Most of the interior looks original except for some new laminate flooring that runs throughout the house. And this is where the showdown begins.

Day 4: (Enter the Insurance Company Adjuster): "Can you show me where the damage is?"

Restoration Contractor: "Sure, the water started here, ran over and under the laminate flooring causing water to spread throughout the entry, down the hall into the kitchen, across the other side hall and into two of the three bedrooms. We've removed all the laminate flooring with water under it and the wet baseboards and drywall, too. The small room off to the side was dry, but we'll have to replace that flooring because they don't make that type anymore."

Insurance Company Adjuster: "We don't pay for that."

Restoration Contractor: "What do you mean you don't pay for that? The flooring's the same throughout the house. It's the same product and can't be matched. We'll have to replace it to make sure everything goes back the same."

Adjuster: "I understand what you're saying, but we won't

pay for that – we only pay for flooring up to where the hall meets the bedroom. We stop at the doorway entrance if the material isn't damaged."

Restoration Contractor: "I hear what you're saying, but the flooring material isn't made anymore. If we replace just the damaged items, the house is going to look funny. The rooms won't match like they did before. It's not the same."

Adjuster: "I get it, but we don't pay for anything past the room breaks."

Restoration Contractor: "What then do you suggest I tell the homeowner?"

And with that, the insurance company adjuster reaches across the hall, grasps the brass knob, gently closes the door and states: "Tell her not to look at it."

Restoration Contractor: "You want me tell her what?!"

Adjuster: "Tell her not to look at it. She can put a rug over it so she won't have to see it." (Exit the Adjuster).

The scene you just read is true. Because that restoration contractor was me. Those words were spoken from a licensed adjuster spewing out the company lines they were educated and trained to say. The insurance company might not have trained their employees to say, "Put a rug over it," but they do educate them to view damage and interpret policies looking for ways to minimize exposure. And this is what causes adjusters to say, "Tell her not to look at it." It's not because these are bad people. On the contrary. The adjuster I met that day was very pleasant and easy to get along with. Unfortunately, adjusters are stuck having to report to the insurance companies who pay their salaries, provide their health care, and hand them bonuses based on performance indexes.

Enter our property owner from Niceville: I repeat the statements from the adjuster. She's not hearing it. She's not going down without a fight. No way, no how. Look out Alex, this little old lady knows how to take the gloves off.

And what pray tell was the conclusion to our tale you might ask? Well, it was a good fight. Phone calls were made to people who could speak on the property owner's behalf and put pressure on the carrier to do the right thing. And, in 2013, one less home in Niceville went without a rug on the floor.

Which Medicare Enrollment Period is Right for You?

Eventually, if you are lucky, you will find yourself needing to make the transition from traditional insurance to Medicare. Knowing when you qualify to first enroll and when to make changes later on can prove a bit confusing, but is critical to make sure you make the right moves at the right time. Missed opportunities and sometimes even monetary penalties which could last a lifetime may otherwise result.

So, let's get right after it, shall we?

There are four types of enrollment periods for Medicare. For the purposes of this article, I will use the term "Medicare" to apply to Advantage Plans, Supplement Plans and Stand-Alone Prescription Plans unless otherwise noted.

Those Enrollment Periods are:

- Initial Enrollment Period
- Special Election Period
- Annual Election Period
- Open Enrollment Period

The first Enrollment Period you will encounter is called the

Initial Enrollment Period or IEP for short. As the name indicates, this is when you are aging into eligibility for Medicare. The IEP is different for everyone as it starts three months before the month in which you turn age 65 and runs until three months after the month in which you turn age 65.

The IEP does expose you to a potential lifelong penalty if you fail to enroll in Part B and a Prescription Plan. Those penalties would apply after you eventually did enroll late and accrue every month after your IEP ended. The penalties will stop accumulating after you get the proper coverage arrangement. Important note: These penalties will not apply to you if you have other qualifying coverage through work or a spouse.

The second Enrollment Period you might encounter is a Special Election Period or SEP for short. This Enrollment Period is for certain types of special events such as moving to a different coverage area or losing your employer or union coverage. The SEP timing is again, unique to everyone as every situation is unique to the person. This Enrollment Period lasts for three months after the month in which the qualifying special event occurred.

The third Enrollment Period you will encounter is the Annual Election Period or AEP. Every year, from October 15th through December 7th, you can switch plans, drop coverage or change

companies for your Medicare coverage. You can also join a Medicare plan if you missed the window for the IEP or SEP described earlier.

It is important to note: Any Medicare plan elections you make during the AEP will become effective on January 1st of the following year.

The fourth and final Enrollment Period you will encounter is the Open Enrollment Period or OEP. Depending on the type of Medicare plan you have (or don't have), you may be allowed to make a one-time election to switch a plan (Advantage Plan) or purchase a plan (Supplement Plan and/or Stand-Alone

Prescription Plan. The OEP runs from January 1st through March 31st every year.

Deciphering all this can be somewhat confusing. Using a broker with experience in such matters will be your best bet. If you have been using a broker that worked with you on your under age 65 plan, that person would be your best first telephone call, provided they also work in the Medicare field as I do. Often times, folks will look to move that under age 65 policy to a broker that works with Medicare at least three to four years prior to becoming eligible for Medicare just to help make the transition as smooth as possible.



Know your Enrollment Periods or discuss with someone who does and your transition will be as easy as Key Lime pie!

Annuities are not for everyone. If however you are considering one or perhaps already own one, this article will address a few key takeaways for you. This is intended to speak to deferred annuities (letting it grow over time vs taking out the income now). Annuities come in all shapes and sizes these days and they have taken on increased interest from the financial media and investors and savers alike in 2020. Cost is a significant factor when examining an annuity and finding out just what you get for the costs is critical, especially if you want to make sure you are locking in any appreciation year over year.

Annuities mainly come in

two different types: Fixed and Variable. The fixed type is simply getting a fixed rate of return each year on the amount you have invested in the annuity. And the earnings or growth is tax deferred until withdrawn. The variable type simply means it is invested in sub accounts, similar to mutual funds, so the rate of return varies with the performance of the subaccounts in your annuity.

Annuities can also have features or benefits added to them and those are called Riders. A rider usually comes at an additional annual cost stated as a percentage of the amount in the annuity each year. One of these Riders is a step up in basis of the death benefit of the annuity. An example of that might be your beneficiary receives no less than your original contribution or the stepped up basis, the appreciated value of the deferred annuity. This is usually of added importance to the variable annuity holder because she or he typically wants to lock in any appreciation from year to year (assuming there is appreciation)

and not have the death benefit be worth less than the amount invested should the market and the subaccounts decline.

In the interest of managing cost and innovation, many issuers of annuities might offer riders a la carte or eliminate them all together. The good news is that will get your investment cost down. The components of cost are usually the annual mortality and expense charge, the management fee of the subaccounts (if it is a variable annuity) and any riders. Investors would want to make sure they know what they are being charged for each year and that there is benefit to them for the charges. And it is usually a seen as a good idea to comparison shop as well.

There are choices available today that make the cost of annuity much less than it has been in the past, which had been a main criticism of them. Investors should take note that when managing costs, they are willing to give up the associated benefits. One of the most often cited by investors is the annual step up of the death benefit. The reason this is so is that many variable annuity holders would want to indemnify their beneficiaries with any growth the subaccounts have experienced. As cost innovation has taken hold over the past decade many issuers offer to eliminate the cost of that benefit or rider and make the variable annuity more of a no-frills annuity. This results in greater cost efficiency which can be a key component to long term returns. They do however give up that benefit. If someone has held a variable annuity for several years and it has appreciated they may not want to lose that opportunity.

What if someone is already in a no-frills variable annuity that does not offer the step up for beneficiaries? They should check to see if they have choices: Can they add that rider if possible? Or, does the issuer offer alternatives that have the rider so that they maintain the increased value if any? Or, they might want to consider a lower risk annuity, the fixed annuity but also making sure that it offers the benefit they are seeking.


Changes to these types of in-



vestments should be thoroughly researched as there may be cost considerations (such as early withdrawal charges) in doing so. Investors would want to be sure they have conducted an analysis of the cost benefit and it meet their needs. Check with your issuer or advisor and be sure to review your options and any associated cost and if it is to your benefit. With variable annuities, any withdrawals may be subject to income taxes and, prior to age 59 1/2, a 10% federal penalty tax may apply. Withdrawals from annuities will affect both the account value and the death benefit. The investment return and principal value will fluctuate so that an investor's shares, when redeemed, may be worth more or less than their original cost. An annual contingent deferred sales charge (CDSC) may apply. A deferred fixed annuity is a long-term, tax-deferred insurance contract designed for retirement. It allows you to create a fixed stream of income through a process called annuitization and also provides a fixed rate of return based on the terms of the contract. Fixed annuities have limitations. If you decide to take your money out early, you may face fees called surrender charges. Plus, if you're not yet 59 1/2, you may also have to pay an additional 10% tax penalty on top of ordinary income taxes. You should also know that a fixed annuity contains guarantees and protections that are subject to the issuing insurance company's ability to pay for them.

Home and Condo Owners Associations... Buyer or Seller, what you MUST know!

A well-run homeowners or condo owners association can be a blessing! However, because I'm an equal opportunity writer, I know that a poorly managed one can be a curse! When you purchase a home in a planned development and/or condo, it might require you to join the community's home/condo owners association (HOA) and pay its fees to help cover things like the upkeep of shared structures, amenities, common areas, exteriors and even some insurance coverage. In addition, to help with the standards of your community,

the HOA membership binds you to the association's covenants, conditions and restrictions, affectionately known as CC&R.

Owners' associations usually have the same goals of maintaining a community's quality of life and preserving property values, and that's a good thing! HOAs offer benefits and services to their members—and members also owe certain obligations to the association and duties to their neighbors. In most cases, a condominium's rules and regulations address more topics and the association plays a more active role than a single family homeowners association, because they oversee the actual building that the condos are in; as a condo owner, you typically own from the drywall in and every other part of the structure is shared with the other condo owners.

If you are looking to purchase a condo or a home that has an HOA, there's a few things to find out before you make a move:

- Know that fees differ

widely. They will be different from building to building, neighborhood to neighborhood and even within a development, due to variations in size, location and orientation.

- Ask how often the fees have increased over time. Ask for the financial history and if there are plans for future increases.

- Find out exactly the what fees include and what they exclude (for example, might cover trash removal, cable, etc. or might not).

- Keep in mind you will pay for recreational facilities with your fees whether you use them or not.

- Know if there are additional fees that may apply i.e. new buyer fee, assessments for special projects, etc. Get copies of the board minutes; find out what the future plans are and if their reserve fund is healthy enough to cover future improvements or if you need to plan for a future assessment. Most developments will have a multiyear plan for repairs and capital investments.

- If financing, ask your lender if fees will factor into your mortgage approval and if that particular association is approved for financing.

- Get a copy of the CC&R and review them. You need to know what you can and cannot do i.e. where to park, size of pet, landscaping restrictions, fence and roof types allowed, etc. In the CC&R, check for language that may have complicated restrictions or even prevent you from renting the property or if there are no rental restrictions.

- Find out the penalties for breaking the rules and how conflicts are resolved.

- Especially with condos, find out what your insurance obligations are vs. what the HOA insurance covers.

- If you want to sell, now or later, find out if there are financing restrictions, if the building is conventional, or FHA and/or VA approved—the more restrictions, the smaller the buyer pool when you're ready to sell.

- Keep on top of what's going

on with your managing board. NOTE: My friend, Bonnie Manthey with Inlanta Mortgage said we've had a complex in our area recently change from being professionally managed to being owner managed and that change alone caused that complex to come off the Fannie May approved list. Again, this can limit the number of buyers who are able to make offers on a condo for sale.

In a nutshell, HOAs offer you having less responsibilities in exchange for some control over your home. Hope this helps and know that whether buying or selling in a owners association area, it's a good idea to engage a professional real estate agent, like me, who is well versed in planned developments and HOAs. I can help you navigate through the ins and outs of purchasing or selling property with an owners association.

Four hundred years ago in September, two vessels were scheduled to sail from the South-

ern coast of England. One vessel, the Speedwell, was deemed unseaworthy. So, her passengers squeezed onboard the second vessel and on the 16th of September 1620 from Plymouth England, the Merchant ship known as the Mayflower with 130 – odd people plus sheep, goats, chickens and dogs set sail on her own for America. In their haste to sail, they forgot to bring along fishing rods.

It is thought that there were around 30 children on board

the Mayflower during her epic voyage to America, but little is known about them. Some were children of the passengers, but some were sent by families who stayed behind. They were cared for by families onboard the ship while other children sailed as servants. Four siblings ages 4 – 8 were given passage by their wealthy father as a means of getting rid of them, because he felt sure their mother had been unfaithful to him and, perhaps, they were not even his children. They were placed in the households of prominent Pilgrims. I will tell you more about them later.

Girls are supposed to be the weaker sex; there were 11 young girls on the passenger list ranging in age from 1 to 17 and all of them survived the voyage. There was one baby born during the crossing, a boy appropriately named Oceanus. Amazingly, only one passenger died during the harrowing 66-day journey across the Atlantic. They landed on the tip of Cape Cod Nov 6, 1620.

Unfortunately, their first win-

ter in the new world was far worse than the treacherous voyage. Due to food shortage and disease, only half who made the journey survived to see spring and the creation of their new settlement. Only one of the four siblings sent by their father, an age 6 boy, made it through the winter. He later married and became quite prominent. The baby boy Oceanus died about the age of 2.

The Mayflower was 90 – 110 ft. in length, 25 ft. wide with three masts and three-four decks. She had a crew of 30 and all passengers ate the same thing every day. The ship had design flaws that made it impossible to cook due to rocky water and high winds.

Compare the Mayflower to today's Queen Mary 2 at 1,132 ft. long with 12 decks and accommodating 2,695 passengers and 1,292 crew, not to mention the exquisite accommodations and fine cuisine.

I was scheduled to host a cruise on Cunard's Q Mary 2 in partnership with Ancestry this year. This transatlantic crossing

from New York to Southampton was to mark the 400th anniversary of the Mayflower Voyage but, you know why that didn't happen. What you might not know is there are 12 generations and 35 million descendants alive today from Mayflower passengers and you might be one of them. This cruise was to have been a "Journey of Genealogy" voyage. Ancestry experts planned to host talks themed around the Mayflower voyage and the stories of the passengers on board. They would also offer the opportunity to trace your family tree through the centuries and find out how your DNA connects you to the world.

While I absolutely love to travel, I also love researching my ancestors and traveling is a great way to do that. Helping others to search their family and discover their roots is extremely rewarding. That is why my husband and I teach genealogy and family history research classes for free and host Heritage and Genealogy Tours

Half of the passengers on board the Mayflower were searching for not only a better life, but religious freedom as well. They were worried that law and order would break down once ashore, so they signed an agreement on the 11th of November—the 'Mayflower Pact'—creating a "civil body politic" which was the United States' first governing document. How interesting is it that 400 years later there is a break down in law and order and many in America today cannot worship in their churches? Our Constitution and many of our freedoms are now at risk, our history is being erased, the American Flag is something to throw to the ground and burn and patriotism is a dirty word. Let's remember those who landed 400 years ago at the tip of Cape Cod in November 1620 to start a new world as we vote in the United States of America this November 2020.

Note: There is a replica of the Mayflower on display at Plymouth, Mass. It was built in Devon, England in 1956-1957.

Don't Forget Canines During Covid

A dog is a man's (or woman's) best friend. They are there for us in good times and the bad, loving us unconditionally. We take care of them the best we can as if they are our own children. But what happens when your hours are cut at work, or even worse, you are let go from your job and you can no longer afford to take care of your best friend? What happens when you have to choose between feeding your companion and feeding your family?

During the last few months many people had to make this tough decision as they faced being furloughed, laid-off, or had their business close permanently due to Covid. These are the times when we could use a canine companion to be there for us most, but many people found they could not be there for their pet, and shelters began to fill up in Walton and surrounding counties as people had to make the tough choice to say goodbye to their four legged friend.

When Steve Kotowski, owner of What's Up Dog, heard that the shelters were starting to fill, he knew he had to do something to help keep more dogs out of shelters and at home with their families. "The therapeutic value of a pet dog is huge especially when people are struggling. People like to cuddle up with their dog," said Steve. "Our dogs do so much just as pets." To help alleviate this tough choice people were facing, Steve bought a palate of NutriSource Choice,



to donate to those who needed assistance.

"We wanted to do it on the honor system, and we definitely wanted to make sure people could get it, and that we give them good food, which keeps the dog from becoming ill, which adds more bills and more stress," stated Steve. "We wanted to have quality food so they would have good nutrition."

What's Up Dog offered in-store and curbside pick up, and occasional delivery when possible. "It was nice to give someone a fist bump and tell them, you're going to be okay," Steve said.

"People need to hear that it's going to be okay, and we're going to get through this. That was the message we started telling people. You're going to get through this."

Steve bought the first 50 bags in April. While the economy is now slowly getting back on its feet, many people are still struggling and some are still out of work. By the time this story comes out, Steve will have a second palate of food to donate, another 50 bags. Because Steve had some people come from north Walton and as far out

as Panama City Beach, he will also have gas cards to give to those worried about not having the gas money to travel. Steve is also working on partnering with local businesses to have more pickup locations throughout the area.

Covid has not only affected our pets, but has also affected service dogs and the people who

need them. In addition to owning What's Up Dog, Steve is also the founder and executive director of Pawsitive Love Foundation, a program that provides service dogs to veterans who experience PTSD. They are a non-profit organization here in Santa Rosa Beach that relies on funding, which has been put on hold due to Covid. While he is continuing to care for, and train service dogs, Steve is unable to meet with those veterans in need

of a service dog to give them exposure training.

Destin Fishing: A Fisherman's Paradise

Fishing in Destin isn't a new phenomenon. It goes back over a thousand years. As far back as the seventh century A.D., the American Indians who called this strip of paradise home survived off the seafood in the area. Hundreds of years later, it is thought that Spanish explorers also relied on the abundance of fish in the area. More recently – and by recently, we're talking approximately 1840s – a fisherman named Leonard Destin settled in this tropical oasis. The fact that this coastal beach town was actually named after a fisherman demonstrates the importance of fishing in the area!

Nearly 100 years later, Destin was officially dubbed the "World's Luckiest Fishing Village." The name has stuck ever since. Locals and visitors can find more information about Destin's fishing heritage at the Destin History & Fishing Museum.

Now, Destin boasts the largest and most well-equipped fishing fleet in all of Florida. Destin's charter fishing vessels take you deep for the big fish. The annu-

al Destin Fishing Rodeo is one of the area's most popular events, drawing dedicated anglers from all over for the largest competition of its kind in the world.

With the popularity of fishing and the Destin Fishing Rodeo, both experienced and novice fishermen are curious about the different types of fishing that dominate the Emerald Coast seascape. Some of the most popular types of fishing include deep sea fishing, inshore and bay fishing, surf fishing, pier fishing, river fishing and lake and pond fishing.

DEEP-SEA FISHING

Deep-sea fishing (or offshore fishing) is just that – fishing in deep waters. This typically means at depths of 100 feet



or more. In Destin, boats travel anywhere between 10 to 30 miles from the shore into the Gulf of Mexico for deep-sea fishing. Destin companies offer a variety of ways to deep-sea fish, including private, charter and party boats. Charters and

party boats provide the necessary equipment, bait, tackle and fishing licenses. Generally, deep-sea fishing trips focus on bottom fishing (dropping a baited line to the seafloor) and trolling (pulling baited lines behind a moving boat).

For many, part of the fun of deep-sea fishing is never knowing what you'll pull up at the end of your line! Types of fish you are likely to catch include snapper, grouper, amberjack, triggerfish, mackerel and cobia. On a charter boat, the captain will let you know if you can keep what you catch based on length, weight, season and other requirements. If you go out privately, rather than on a for-hire trip, make sure you are prepared. This means bringing the appropriate gear, obtaining your fishing license, researching the rules on what you're allowed to keep, and knowing where to go. Keep all of this in mind, and you're bound to have a great deep sea fishing experience.

INSHORE & BAY FISHING

Another popular pastime on the Gulf Coast is inshore and bay fishing. Unlike deep sea fishing, inshore and bay fishing is done closer to the shore, in calmer waters than those of the Gulf. This includes anything from bays to estuaries to anywhere else falling within nine miles of the shore. Inshore fishing boats are smaller and faster than offshore fishing boats, and the equipment required is typically

lighter. It tends to be more consistent throughout the year, and there is more time to fish due to shorter travel times to get to preferred fishing locations. Another difference between inshore and deep-sea fishing is that you will usually be casting when inshore fishing. Again, Destin fishing charter companies will provide the bait, equipment, and fishing license required for a bay fishing trip. Common fish you're likely to see and catch while bay fishing in Destin include redfish, speckled trout, flounder, black drum, sheepshead and catfish. When hiring a boat for inshore and bay fishing, you'll have to book a private charter, meaning you have the flexibility to spend anywhere from half a day to a full day on the water.

SURF FISHING

Moving even closer to the shore, surf fishing is when you stand on the shoreline or in the shallow surf to catch fish. Surf fishing can happen anywhere from sandy beaches to rock jetties. In Destin and along the Emerald Coast, the best time to go surf fishing is between March and November; although, warm winters can result in good surf fishing year-round. The best of day for surf fishing is when the tide is rising or falling. Even though you can surf fish from anywhere along the coast, certain locations will yield better results. Try looking for color changes and where the waves

break. The darker colored water hides deeper holes, and you're more likely to catch a fish in these areas. Additionally, irregular patches of the beach are also good feeding spots. When surf fishing in Destin, pompano and whiting are prize catches; however, other fish such as redfish, ladyfish, blue runners, bluefish, sheepshead and more are also available. One of the great things about surf fishing in Destin is that it's fairly easy to go from your beachfront vacation rental right to fishing on the crystalline shores.



of fish you catch will depend on the time of year that you go. Throughout the year, expect to catch anything from redfish, flounder, bonito, pompano, cobia, mackerel, bluefish, ladyfish and more.

of the Gulf Coast are not just pretty landscapes to look at and enjoy. Their fresh and saltwater ecosystems depend on varying factors, but it's this uniqueness that provides a great fishing environment. Typically, the fish found in the coastal dune lakes are freshwater fish; however, you may catch some saltwater species as well. Among the most common types of fish caught are bream, bass, catfish, redfish, flounder, speckled trout and mullet. While many of the lakes are surrounded by private property, there are a number of public access points for anglers to use to get to the lakes. Enjoy the quiet seclusion that the dune lakes and surrounding coastal environment provides.

PIER FISHING

Pier fishing is common on Okaloosa Island and Panama City Beach. As the name suggests, pier fishing is casting a baited line from a fishing pier. Like surf fishing, pier fishing has its advantages, as you don't have to worry about a boat and heavy equipment expenses. The difference between surf and pier fishing is that you can cast into deeper waters when pier fishing. Along the Emerald Coast, there are a number of piers where you can cast your line and catch some fish. These include Okaloosa Island Pier, Pen-



sacola Beach Gulf Pier, Navarre Pier, Russell-Fields Pier and MB Miller Pier. You can pier fish year-round, and the type

RIVER FISHING

Although much of the focus in Destin is fishing in the saltwater of the Gulf or the unique ecosystem of Choctawhatchee Bay, river fishing is also a popular sport. Taking a boat out on the Choctawhatchee River, East River, or other nearby rivers and creeks can be a quiet and relaxing experience. Head out on a small motorboat or kayak and bring your fishing gear for a relaxing day on the water. The Choctawhatchee River specifically is great for catching redfish and speckled trout. Focusing on the river mouth or near rock piles may increase your chances of catching a fish. As always, be sure to obtain the appropriate fishing license before river fishing.

THE LUCKIEST

There you have it. These are the most popular types of fishing in Destin and all along the Emerald Coast. With such amazing fishing opportunities, it's easy to see why Destin is considered the "World's Luckiest Fishing Village."

LAKE & POND FISHING

Finally, some anglers enjoy lake and pond fishing in Destin. The rare coastal dune lakes

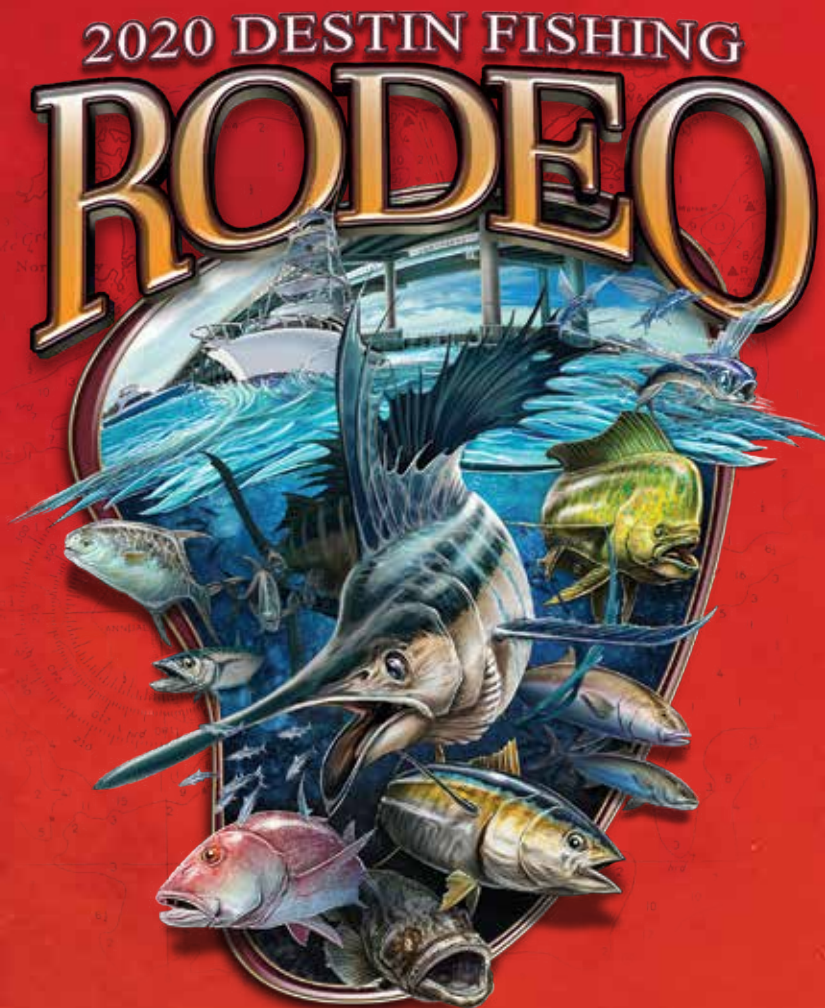

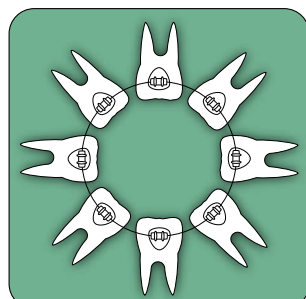

Reducing stress (#7 in Part 2 on strengthening the immune system) is one of the ways we can help our immune system. It's also one of the most difficult

because it's unavoidable. There are two types of stress—psychological and physical.

In very basic terms, your brain recognizes a stressor (a stimulus that causes stress), and a message is sent to the pituitary gland which tell your adrenals to increase the amount of cortisol (stress hormone) circulating in the blood. This hormone works by providing an energy boost during periods of stress. Examples of this are a student preparing for an exam or information overload during a major

event or oncoming hurricane. These stressors are short-lived, so the impact on our immune systems is minimal.

When stress lasts for longer periods of time, the elevated cortisol suppresses your immune system by reducing production of white blood cells, which are responsible for battling germs. How many people have you known that return home from vacation with a cold?

It's important to recognize when your stress is lasting too long. But, why get stressed about

being stressed when we can begin finding moments in our everyday life to decompress? So, STOP trying to 'push through' and take a break. Close the laptop, silence your phone and take a walk around the block, water your outdoor plants, listen to some music while you sit in the shade. Brief gaps are known to be stress-reducers and taking time outdoors is proven to help you decompress in your most needed moments.

Music can also make a difference; something soothing that

can relax the mind. What about playing games with family or friends, exercise, etc.

Whatever you choose, listen to your body and make the necessary lifestyle changes to give your immune system the care and nourishment it needs. It really will make a difference.

“I’m sorry. I was wrong. I can see that I hurt you and I shouldn’t have done that. I value our relationship. I will make every effort not to do that in the future.” Wouldn’t it be so helpful to hear that when someone hurt you?

What we often get instead is... “I wouldn’t have done that if you hadn’t...” Or, “I’m sorry you’re so sensitive.” Or, “I’m sorry your feelings are hurt, but the reason I did this is because you...” Or, often we get silence and are expected to move on in a relationship with no acknowledgment or resolution around the hurt.

If you’re like most humans, you appreciate and need a sincere, heartfelt apology as a part of repairing a relationship. How-

ever, it’s often easier to receive an apology than to give one. Apologizing is the humbling act of taking direct, verbal responsibility for something hurtful you’ve done to someone else. And, following up the verbal apology with a behavioral commitment to change your behavior to prevent repetitive hurt. Apologizing is a cornerstone of healthy relationship.

If apologizing is hard for you, you might have some of the following common objections to saying you’re sorry:

- I didn’t intend to hurt anyone.
 - Parents aren’t supposed to apologize to their kids.
 - The other person hurt me, too, and they need to apologize first.
 - If I apologize, I’m giving away power I have in the relationship.
 - The other person deserved the hurtful thing I did.
 - I don’t do anything wrong, so I don’t owe anyone an apology.
- While these objections can be

powerful motivations preventing an apology, the cost is a disconnected relationship that lacks trust and accountability. Apologizing is non-negotiable if you want an honest, reciprocal, trustworthy relationship.

So, you know you need to apologize, but how do you get it right?

Five Things NOT do when Apologizing:

- Don’t make excuses. Someone you’ve hurt is not interested in why you hurt them.
- Don’t lecture. If there is something you want the other person to do differently in the future of your relationship, address that issue at a separate time, not on the heels of your apology.
- Don’t use an apology to get results. Apologize because you care and you have remorse for hurting the other person. Don’t apologize to get the other person to quickly move on from their pain, to finish a work project, or to move back to life as usual because this is more comfortable for you.

• Don’t insult the hurt person’s emotional experience. “I’m sorry you’re so sensitive” is not an apology. It’s an insult and indicates no responsibility for your hurtful behavior.

• Don’t demand forgiveness. The hurt person gets to decide how they will receive your apology. If they choose to forgive you, they get to decide that in their own time.

Five Things TO do when Apologizing:

- Take full responsibility for your part. Reflect on what you understand was hurtful behavior on your part. Say you’re sorry and say specifically what you did that was hurtful. “I’m sorry I stood you up for our lunch date.” Even if the other person did something hurtful to you in this situation, now is not the time to say it. Own your part and hold them accountable for their part in a separate discussion.
- Validate the emotion of the hurt party. “I can see and understand that it was hurtful to you

when I did not show up for lunch.”

• Communicate the value of the relationship. “Our friendship is important to me and my behavior did not reflect that.”

• Communicate and follow through on a plan for change. “I commit to doing better in the future. If I make plans with you, I will show up or let you know in advance if I have a change of plans.”

• Keep it simple. Apologize and leave it at that. Correcting, lecturing or explaining your behavior will only take away from the apology.

While apologizing can be difficult at times, it’s a healthy practice that causes self-awareness, personal growth and relational maturity. There is something freeing about admitting you are wrong sometimes and taking the steps to make things right. A sincere apology followed by behavioral change can be profoundly healing in any relationship. For more emotional and relational health resources, visit journeybravely.com.

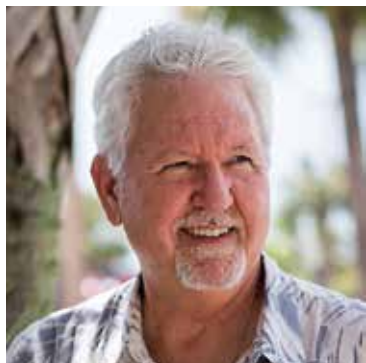

I saw a young couple walking on the beach. Hand-in-hand. They removed their surgical masks and made conversation. I said hello to them, but they didn't hear me.

You can't hear anything on a beach. It's too loud. One of the things I love about it.

As it happens, I once stood in this exact spot when I suffered my first case of heartbreak. I was hardly a teenager. I stared across this dark water at constellations and wished God would've made me better looking. I felt like the ugliest boy on earth.

I also visited this shore the night before I got married. It was bitter cold because it was December. Even though I was overjoyed about my upcoming day, I felt lost.

I don't have a big family. The little family I did have fell apart when my father died. A wedding brought all that to the surface.

So the night before my ceremony, I walked to this beach and listened to the surf. For hours.

People don't realize how special the white noise of the Gulf is. It's like a voice. A familiar one. One you recognize from far away. Like your mother calling you. Only this mother can kill you if she wants. She is as fierce as she is beautiful.

She's fed by 33 major rivers that carry water from 31 different states. She was formed in prehistoric times by the Mississippi River and other rivers that spewed mud and grit into her basin.

These seafloor deposits turned into reefs. The reefs turned into land. The land turned into a Floridian peninsula. And this peninsula turned into high-rise condos.

In her tummy are 2,000 known historic shipwrecks spanning 500 years of maritime history. From the Spanish explorers to the American Civil War. Also, I've lost my keys here at least six times.

I worked as a lifeguard on this beach for a little while. I've seen some weird things happen in this wild water.

I've seen swimmers caught in rip currents, lulled out to the end of the world, only to reappear miles downshore, alive and confused.

And one time, only hours after we saw a swimmer die of hypothermia onshore, a wedding took place on the same

sand. The bride had no idea.

I've seen young men and women baptize themselves here. Most of them in street clothes.

I've watched elderly Europeans, who don't believe in Speedos, suntan naked here. People whose body parts have been ravaged by the effects of gravity.

I have camped beside this Gulf in a pup tent. Which was, technically, against the law. But nobody cared back then.

Every dog I ever loved has frolicked in this green water, chasing sticks and stuffed ducks.

I've seen weathermen stand where I'm standing, in tropical winds, putting on a good show for the cameras. They flailed and hollered like they were in a war zone, while their cameramen held coffees and danishes.

I've seen this Gulf get so mad that it swallows everything, tries to kill everyone, snaps hundred-year-old oaks, ruins mainstreets, and upheaves the shore.

I've caught redfish here with nine-dollar rods. I've seen the Blue Angels fly overhead in such a patriotic display that even buck naked Europeans put hands over their hearts.

I've seen church people lug portable electric organs onto the sand. I've attended bonfires where parents said goodbye to

sons who were leaving for Parris Island boot camp.

I once played baseball here, barefoot. I cut my foot on an oyster shell when sliding into second.

I have seen families—more than I can count—scatter the ashes of loved ones into the clear blue drink.

And once, I held my wife on this shore. The day after her father died. She cried into my shoulder because losing someone feels worse than dying.

The young man and woman found a place near the water. They sat.

They burrowed into the sand using only their haunches. They wrapped arms around each other. She leaned onto his shoulder. They kissed. And it was perfect.

Florida has more cases of COVID-19 than most states. We are a mess right now. And I don't know when it will be over. I hope soon.

But in the midst of a worldwide endemic, I saw love. It was on a seashore. It was undiluted and thick, like cake batter. The purest kind. The kind that can only be found upon the doorstep of heaven. Or at home.

Or right here in Destin.

Over the past four months, you've heard the chamber say this when talking about the economy: Reopen, Recover, Reimagine. While we've reopened, the recovery is ongoing and the reimagine is being discussed. Our Economic Recovery Task Force has done a great job providing the chamber with thoughts and ideas on what's to come.

One of the major events just ahead of us is an election that has not received much attention due to the coronavirus pandemic. When you go to the polls, we ask that you vote for pro-business, pro-quality growth, and pro-citizen candidates. We encourage you to do your research and learn who is pro-business.

Reopened. Recovering. Reimagining.

Coming out of a downed economy, we need elected officials who support the business community.

Also, ahead of us in November are four constitutional amendments, and for those who live in Destin City Limits, a charter change concerning building heights. One of the constitutional amendments is a mandatory \$15 per hour minimum wage. The Destin Chamber is opposed to this for several reasons:

1) This is an issue that can be and should be handled legislatively, if the Florida Legislature wanted to pursue this. The Constitution is no place for this mandate.

2) Coming out of a terrible economic downturn, this is one of the worst things that could happen to the business community. Small and large businesses alike do not need another expensive mandate.

3) If passed, businesses will either have to decrease expenses or raise prices to be able to afford the rate increase.

4) Servers and bartenders in

our restaurants actually stand to lose money because of the taxing structure and mandates on tipped employees.

5) As businesses look to decrease expenses, many full-time employees will be shifted to part-time so the business does not have to pay benefits to those employees. That means there will be more working people

who lose benefits such as health, dental and vision insurance. The loss of those benefits could cause greater problems down the road. OR the businesses will become more automated with self-service checkouts and kiosks for ordering, which will eliminate jobs and causing unemployment to increase. Loss of income from reduced hours will also be a negative. There are many other reasons to oppose this amendment, but I only have limited space to write. We encourage you to vote NO on this issue.

Destin City Council has



passed a City Charter Amendment to be on the ballot as well. This amendment would place in the city's charter a limitation on building heights to six stories or 75 feet. Anyone who wishes to have a building higher than that would have to wait for the next election, and the voters would decide whether to allow the building to be higher than 75 feet. This could not only control development, but stop it completely. Just like the minimum wage, it's a legislative issue for council to decide. Development can mean other things, not only condos and/or residen-

tial units. If city council wants quality development, something we all should desire and work toward, perhaps parking garages could be built in the Harbor District, something promised to the businesses there years ago when those businesses agreed to allow the city to build the boardwalk along the harbor. Parking garages would relieve the traffic on Harbor Boulevard, especially in the summer and are the only piece of public infrastructure that pay for themselves.

The Destin Chamber opposes the amendment to the City Charter that would restrict building heights and ask citizens to vote on any building higher than six stories or 75 feet. We encourage you to vote NO on this issue.

Casey Kearney: Follow Your Dreams Because "Better Days" Are Coming

It's a hot sunny Saturday in Montgomery Ala., and there in a dusty steel arena, kicked back in a folding chair, watching her three children and husband compete in various rodeo events, sits Casey Kearney. An unassuming 30-something who I was watching, just two weekends before, at a live concert as she filmed the video for her first single to achieve country radio airplay.

The day after the 16 hours of rodeoing and traveling, this same mom/songwriter/performer/teacher was partaking in this very interview, because she had to get this in on a Sunday so she could homeschool her three kids on Monday. Well, that, and there are always horses to feed, chickens to gather eggs from, and the typical never-ending chores that go along with farm life. Did I mention she also has a new album dropping soon? That's what you call a balancing act, and that seems to be the real-life and times of small-town country girl turned popular Northwest Florida music sensation, Casey Kearney.

Your inspiring entrance into writing and performing came once you were already a wife and mom. Tell our readers a little about your musical background and how you came to be Casey Kearney the performer.

I honestly did not know I could actually sing until my late 20's. I could not play any instruments and I had never written before. Both of my parents sang when I was growing up and both were amazing, but I never did. Songwriting started as an outlet to release feelings I was dealing with at the time, then evolved into something I really enjoyed. I had an extreme case of stage fright and that took a lot of work to get over. Learning to play instruments between nap times and laundry loads was challenging. I had two little ones and was pregnant with my third. When I meet musicians that have played their whole lives I think, wow, don't take that for granted, I've been playing catch up my whole career!

In 2016 I reached a now or never moment. The kids were slightly older, and I knew that



music was something I absolutely had to pursue. I really buckled down on learning to play guitar, and I went to Nashville to record my first EP. It was expensive, but I charged it on a couple of credit cards, determined to pay for it myself before the interest hit me hard. I did and it felt so good. I just continued to press on from there, learning several other instruments and developing artistically.

Where does your desire to create come from, and where do you want to take that? What does the ideal future hold for you?

I think the desire to create is a gift that God gives us. Whether we choose to use it or not is on us. It is one of those things that is just in you. If I am not making music, I am building, remodeling, painting or creating something, somehow. It's who I am.

I've always been impressed with your ability to cover tunes in your own voice, but moreover your writing and lyrical content in your original tunes. Where do you draw that inspiration from?

Real-life. I would consider myself a literal writer. I can paint a picture with words, but it's typically going to be a pretty clear message, not as flowery and abstract as some. So much of what I write comes from pieces of my life, stories I hear, and things

I am feeling or am passionate about. I need to connect to the words on some level.

I've asked everyone from Jimmy Buffet to Kenny Chesney to Darius Rucker if they consider themselves writers or more so performers, and which side is more important and fulfilling for them as artists. What about for Casey Kearney?

I started out dealing with an extreme amount of stage fright; it was a huge hurdle to overcome. I eventually learned the power of stage presence, how to connect with an audience. I realized how much of a performer I am, even if I didn't know it was in there. As for songwriting, when I write something that I connect to so deep, it brings a smile or tears; that's when I truly realize what songwriting is. I honestly feel very connected to both almost equally.

You recently completed a new album in Nashville. I particularly like "Waffle House," "More to the Story," and your first single from the album, "Better Days." Tell us about the new album, and what it was like to already hear "Better Days" being played on country radio's Sirius XM The Highway that first time.

I am so excited and proud of this album. I released other projects here and there, but

this full album of originals was what I really wanted. It is full of songs and stories of my life and friends' lives. There are lyrics from the depth of my soul and some dripping in sarcasm. The whole project very much embodies pieces of my personality.

We would've had it out by spring, then the pandemic hit. But, we had enough done on "Better Days" to release it as a single. When I have introduced this song at shows, I would say, "This song is a pep talk that things won't always be rough and better days are coming for you." It couldn't have been more perfect timing. Hearing my song played on Sirius XM The Highway was something I never thought would happen. When Buzz Brainard said "Welcome to The Highway Casey Kearney!" My jaw dropped. The whole experience felt like a dream...I thought it would be the coolest thing of 2020, but then a few weeks later I was invited to sing our National Anthem for the Atlanta Braves, and that was just over the top awesome. Especially as a lifelong Braves fan! Even though I had to film it in the hallway of my house, seeing the

video of it playing in the stadium was a moment I will never forget.

I know you've been blessed to continue to book shows throughout the summer. What has the whole playing through a pandemic been like for you?

As a musician, I joked a lot that we found out how "non-essential" we were. When restaurants aren't even allowed to be at full capacity, hiring a musician for only 25-50% occupancy doesn't make sense.

I feel so extremely blessed to have been able to play for venues that got us back to work as soon as possible. Several even made sure to book make-up dates when we opened back up. I have played more private parties this year than I ever have. I love being a part of special events, whether it's celebrating a milestone occasion, a vacation bonfire, or one of many corporate parties lately.

My gig schedule is unique because I choose not to play every night. I homeschool my three kids, and they are very active in rodeo, so I like to be there for as

much as I can. I typically play 2-4 nights a week. This year on average, 1-2 per week have been public shows and the others private.

I think your life is more country than most any country artists I personally know. Tell our readers about the Casey Kearney behind the scenes, the farm living wife and mom and some of the activities beyond the stage.

Yes, we live in the woods—three miles of orange clay dirt road. It is a very small rural area about an hour from the beach. At home we have horses, cows, dogs, goats and chickens. My husband and three kids all rodeo. My favorite thing to do, besides music, is to ride my horse, but I don't put in the effort they do to get as good as they are in rodeo event. I got shows to do and can't afford to get hurt.

Where do you want to be in five years professionally? What's the dream Casey Kearney is working toward?

It sounds really nerdy and

cliché, but my ultimate dream is to enjoy whatever stage I am on, or at, in life. I just want to play music that I enjoy creating, and do it for people that like it. I am blessed to live in a region that is so supportive of musicians and creative people of all types. I love my family, and I love making music, and I strive to find balance in both. Sometimes I get it and sometimes I fail miserably. I just want to look back knowing I tried and did my best at both.

You're always one of the favorites for all the members, locals and tourists who attend our Mattie Kelly Concerts in the Village shows. What's it like to play to that crowd and for such a good cause as this local non-profit benefits the arts in Okaloosa and Walton counties?

I absolutely love playing the MKAF show each year! I really appreciate the beautiful stage and top-notch sound ya'll provide us artists. The crowd is always there to have a good time at those shows, and it's an awesome concert series I'm honored to be a part of. MKAF is an organization I truly believe impacts our surrounding
